Subject: Forty-third meeting of the Scientific Group under the London Convention and the fourteenth meeting of the Scientific Group under the London Protocol

1 The Secretary-General wishes to advise that the forty-third meeting of the Scientific Group under the London Convention and the fourteenth meeting of the Scientific Group under the London Protocol, originally scheduled from 9 to 13 March 2020 but postponed due to the COVID-19 pandemic (Circular Letter.4213, dated 6 March 2020), has been re-scheduled and will now take place by correspondence from Monday, 6 July to Friday, 18 September 2020.

2 The meetings will be conducted in English only. The provisional agenda for the meetings (LC/SG 43/1), prepared on the basis of the Work Programme of the Scientific Groups and the directions of the forty-first Consultative Meeting and the fourteenth Meeting of Contracting Parties, remains unchanged. Further documentation, including a revised annotated agenda (LC/SG 43/1/1/Add.1) containing actions proposed by the Chair of the Scientific Groups on each agenda item/sub-agenda item to be considered by correspondence, will follow in due course in advance of this meeting of the Scientific Groups.

Submission of documents

3 Documents that have already been submitted to this meeting of the Scientific Groups remain valid; these are available on IMODOCS. Further submissions during the correspondence period of the meetings will be limited to those responding to the actions proposed by the Chair of the Scientific Groups in the revised annotated agenda in document LC/SG 43/1/1/Add.1, which will follow in due course. The deadlines for the submission of documents to the meetings and the method of submitting documents are specified in the notes in annex 1.

Contracting Parties and observers are invited to submit comments in accordance with the schedule detailed below no later than the deadlines stipulated under each section. Period for comments: Monday, 6 July 2020 to Friday, 31 July 2020

Contracting Parties and observers are invited to submit comments on the actions proposed by the Chair of the Scientific Groups on agenda items 1 to 15 as contained in document LC/SG 43/1/1/Add 1. Shortly after this deadline, the Chair of the Scientific Groups will prepare and submit a draft report of the meetings for consideration and adoption by the Scientific Groups as document LC/SG 43/WP.1.

Section 2: Agenda item 16 – as set out in document LC/SG 43/WP.1

Period for comments: Monday, 7 September 2020 to Friday, 18 September 2020

Contracting Parties and observers are invited to submit any comments on the draft report (LC/SG 43/WP.1), after which time the report will be finalized and published on IMODOCS as document LC/SG 43/16.

4 Contracting Parties and observers are invited to submit all comments to info@imo.org in accordance with the deadlines set out above.

5 Communications from Contracting Parties and observers in response to document LC/SG 43/1/1/Add.1 will be published in English only as they are received.

6 The documents submitted for this session of the Scientific Groups are available on IMODOCS, but not available to the public unless specifically requested by the submitter.

Processing of comments by delegates on draft actions proposed in document LC/SG 43/1/1/Add.1 and LC/SG 43/WP.1

7 Documents providing comments submitted in response to document LC/SG 43/1/1/Add.1 and LC/SG 43/WP.1 will be published on IMODOCS as soon as possible after receipt. Documents must be submitted by a registered participant for this meeting pursuant to annex 2.

8 In order to facilitate the prompt processing of documentation submitted for this meeting of the Scientific Groups, Contracting Parties and observers are requested to follow the guidelines on the Scientific Groups' organization and its method of work for the submission of documentation as modified and explained below:

- .1 documents submitted in response to document LC/SG 43/1/1/Add.1 and LC/SG 43/WP.1 should be in Word format, no longer than six pages in length (non-bulky documents);
- .2 documents should reach the LC/LP Secretariat by the deadlines set out above for each section;

- .3 documents should be submitted in Word format to info@imo.org;
- .4 for reasons of economy, documents should be submitted in single spacing, be as concise as possible and, in order to standardize the presentation of documents, the following word-processing format should be observed:
 - format: Microsoft Word;
 - font: Arial;
 - font size: 11;
 - justification: full; and
 - margins: 2 cm top, 2.5 cm bottom, left and right.
