CONVENTION ON THE PREVENTION OF MARINE POLLUTION BY DUMPING OF WASTES AND OTHER MATTER, 1972 AND ITS 1996 PROTOCOL

JOINT WORK PROGRAMME (2017-2019)

1 In 2008, the governing bodies agreed that a Joint Work Programme (JWP) for the London Convention and Protocol should be prepared that outlines the tasks and activities undertaken by Contracting Parties and their meetings in relation to the two instruments. The JWP should be updated directly after the session of the governing bodies at the end of each year and would serve as a reference document at the start of the new meetings' season. On this basis, the governing bodies and their subsidiary bodies would focus their discussions on future work set out in the short priority tables (appendices I, II and III of the annex), as used in previous years (LC 30/16, paragraphs 13.12 to 13.16).

2 In accordance with this decision, the JWP, as set out in the annex, has been updated in light of achievements and decisions at recent sessions of the governing bodies and incorporates, as instructed, the activities given to the LC/LP Scientific Groups and the LP Compliance Group. It covers the period 2017 to 2019.

3 In 2016, the governing bodies adopted a Strategic Plan for the London Convention and London Protocol (LC 38/16, annex 2). The Plan is intended to facilitate the implementation of the two treaties in order to contribute to the prevention of marine pollution and to advance the 2030 Agenda for Sustainable Development. The Plan also has a clear mandate to promote the ratification and accession to the London Protocol. Recommendations on how to operationalize and implement the Plan will be developed under the lead of the two Vice-Chairs in the intersessional period. Once the implementation plan has been finalized it will be integrated into or replace the JWP.

4 This cover page and the introduction and table of contents of the annex are distributed in the English, French and Spanish languages, whereas the remainder of the document is kept in English only.

5 This Joint Work Programme (JWP) outlines the tasks and activities undertaken by Contracting Parties and the Secretariat in relation to the Convention and Protocol and includes the activities given to the Scientific Groups under the London Convention and Protocol and to the Compliance Group. It also includes target completion dates and a priority level for each activity ranging from low (L), medium (M) to high (H). This document is intended as a task-oriented reference through its provision of information on activities, contacts and status.



It is also intended to provide Contracting Parties and non-Contracting Parties with a better understanding of Convention/Protocol activities. It is updated by the Secretariat each year and is reviewed yearly by the governing bodies. Note that the JWP for 2017-2019 has been reorganized to more closely follow the structure and items on the most recent agendas for the respective meetings of the governing bodies and their subsidiary bodies.

APPENDIX II

FUTURE WORK PROGRAMME OF THE COMPLIANCE GROUP UNDER THE 1996 PROTOCOL TO THE LONDON CONVENTION 1972

The following work programme of the Compliance Group up to and including its 10th session in 2017 was approved at the 11th Meeting of Contracting Parties to the London Protocol, held at IMO from 19 to 23 September 2016. The future work programme is as follows:

- .1 treat individual submissions of possible non-compliance as a priority in the work programme when they arise;
- .2 continue working relationships with other relevant LP groups;
- .3 continue to review dumping reports referred to the Compliance Group pursuant to paragraph 6.2 of the CPM, including where concerns have been identified by the LP Scientific Group;
- .4 consistent with the CPM, assist non-Contracting Parties requesting support in acceding to the Protocol;
- .5 assist Contracting Parties to meet compliance obligations, and support interested non-Contracting Parties in strengthening reporting and other requirements that would facilitate their accession to the Protocol;
- .6 continue to identify and review the factors contributing to the difficulties experienced by Contracting Parties in fulfilling their reporting obligations under article 9.4.1 of the Protocol; identify and review the factors contributing to the difficulties experienced by Contracting Parties in fulfilling their reporting obligations under article 9.4.2 of the Protocol; identify options to address those factors; and make recommendations for improving the rate of reporting under the Protocol and keep under review the presentation of the information contained in the reports;
- .7 examine reports received under all relevant LP articles, use these results in combination with historical documents to clarify the intention behind these requirements, and develop materials to facilitate compliance with these reporting requirements;
- .8 ensure historical documents related to the development of the London Protocol are available to Contracting Parties;
- .9 review and develop materials and inputs regarding its role in compliance promotion in collaboration with the Secretariat;
- .10 facilitate the creation of tools to support the development of implementing legislation for the London Protocol; and
- .11 develop recommendations to increase participation in the group, including potential revisions to the Compliance Procedures and Mechanisms, for submission to the next Meeting of Contracting Parties, in 2017 as per paragraph 7.31.2 of document LC 37/16.

At the seventh session of the Compliance Group, held in 2014, it was decided that the group would benefit from a detailed work plan outlining the specific tasks to be completed in support of the items outlined in its future work programme. This detailed work plan will continue to be used and developed intersessionally, and presented to the group for review.
